
The merger was completed in January 2011.

# Adapt Seoul Agenda to music education



### Goal 1: Access

Access to music education and active music participation is a **human right** which has to be ensured for people of all ages and all backgrounds.

Music education including participatory approaches with active music-making must be a **compulsory aspect** of the curriculum in all schools.



### **Goal 2: Quality**

Focus on how to reach high quality in music education, since this contributes to the personal development.

Music Teacher Training must be **modernised** and the teachers equipped with the most up-dated methods and tools, **continued professional development** is necessary.





## Adapt Seoul Agenda to music education

### **Goal 3: Social and Cultural Challenges**

Focus on the extrinsic values of music education and its potential for social responsibility and intercultural dialogue without forgetting the intrinsic value of music.

Music is a powerful **tool for inclusion** and building bridges and for meeting the social and cultural challenges of European societies.







## Singing and Music Education

At the **conference on Singing and Music Education** in Vilnius in 2009, the participants formulated recommendations based on lectures and research presented which proved that

"Singing together is an educational, social and artistic phenomenon that ensures **intercultural understanding, social integration** and respect for others, contributing to the physical and mental **health** of citizens and therefore the society in which they live and work."







# Singing and Music Education

Thus not only music education must be compulsory, but a curriculum of singing together must be accessible to every child in every school and singing in groups must be encouraged in families, in different parts of society and in all kinds of institutions with singers of all ages.

Also projects involving group singing must be awarded **high priority funding** and be staffed by musically and pedagogically **qualified teachers** and conductors.







## Singing and Music Education

Since singing in groups

- contributes to the improvement of students' **skills**
- has an impact on the singers' health
- empowers **human qualities** and helps decrease violence and crime
- is essential to the preservation of intangible **heritage**

the recommendations on Singing and Music Education are addressed to the **Ministries of Education**, **Culture**, **Health and Social Affairs** 







# Examples of Good Practice

**Singing Poland** – a programme for the development of school choirs, aiming at the creation of 300 choirs in Poland

Jedem Kind seine Stimme and Singen macht Sinn – two German initiatives to increase singing in primary schools and improve the training of students and teachers for singing with children

**Anti-Drug Choirs** – the creation of boys' choirs in the frame of an Anti-Drugs Campaign in Lithuania
